- 5) The customer shall be supplied with a copy of this letter, an extract of the conditions and maintenance schedule, if any, recommended by DNV Product Assurance AS and copy of instructions booklet detailing operation & maintenance of the equipment so as to maintain its safe characteristics.
- 6) The IS/IEC 60079-17 and IS/IEC 60079-19 shall be followed for maintenance and repair of overhaul of the subject equipments.

This approval is liable to be cancelled if any of the conditions of the approval is violated or not complied with .
